Non-GWRRA Riders/Co-Riders may participate in the TRC course if class space is available at a cost of \$60.00 per trike.

Riders/Co-Riders must wear full protective gear as defined by GWRRA (DOT HELMET, EYE PROTECTION, FULL FINGER GLOVES, LONG SLEEVED JACKET OR SHIRT, FULL LENGTH PANTS & OVER THE ANKLE BOOTS OR SHOES)

Riders must have valid operator's license with motorcycle endorsement and provide proof of motorcycle insurance coverage.

Registrations are accepted on a first-come basis. **Class size is limited.**

Submitting this form does not guarantee a place in a course.

A confirmation Notice will be your proof of acceptance into a course.

Courses will take place rain or shine. NO refunds due to weather.

GWRRA member cost for all courses is \$35.00 **per bike or trike.**
 No Refunds; if you are unable to attend, it is your responsibility to get a substitute in your place.
 GWRRA of Indiana reserves the right to cancel or reschedule courses.
 In the event of a **cancellation** by GWRRA of Indiana, fees will be refunded.
